## CAMPING ARCO RULES

This document testifies to registration at the Arco Camp-site and is necessary **for collecting your documents** and for **paying** at departure. **Check out and departure must be before 12.00 am.** for the camp-site and **before 10.00 am.** for the bungalows and small apartments, otherwise an extra day will be charged. **The cash-desk is open for payment from 08.00 am. to 12.00 am. and from 04.00 pm. to 08.00 pm.** and it is possible to pay also with credit card.

**Outside this time it is not possible to pay!**

With the car is allowed to drive in and out **only between 08.00 am. and 11.00 pm.**, and on foot you can enter between 11.00 pm. and 08.00 am. and only by using the **PIN number which will be written here below at the check in.** In case you need to leave the camp-site before or after above time, please leave your car in the parking place outside the camp-site. Between 01.00 pm. and 03.00 pm. you are kindly asked to drive inside the camp-site only if it is really necessary.

### **GENERAL REGULATIONS :**

All fountains and taps inside the camp provide drinking water and they discharge into the Sarca river, therefore nothing else can be discharged except the water itself. Parents are always responsible for their children; the management declines any responsibility. Dogs are allowed in the camp-site but they must be keep on a lead. **All noise is strictly banned between 11.00 pm. and 08.00 am. and between 01.00 pm. and 03.00 pm.** Urgent messages will be stuck up in the notice board outside the reception. The management declines responsibility for any objects that are not deposited in the special safe-deposit boxes, especially objects kept in the tents or caravans as well as apartments. In case that any objects are found they should be handed in to the management, who will keep them at the disposal of the owners. For the use of camp-site's structures please look at the reception for regulations and opening times (Swimming pool, tennis ground, bowls, beach volley, ping pong, multi-use sport-ground, boulder room, internet corner, ... ).

**In this Camp Site is used the recyclable waste collection: the waste must be deposited at the resource collection point near the entrance, rubbish must be disposed separately in the designated containers.**

**ANYONE FAILING TO COMPLY WITH THESE REGULATIONS WILL BE ASKED TO LEAVE THE CAMP SITE.**
